Town Forum AGM - Chair's report 27th November 2019

How time flies. In thinking about what I should say tonight, for my 3rd annual report – remember that chairs are only supposed to be appointed for 2 years – so much seems to have happened.

I am about to make a prediction about next year, so I won't be accused of 2020 hindsight (the sharper witted of you will note the clever pun). This is not to make political point, but to illustrate a point I made last year about the parallels between Brexit and Calverley Square. Whatever happens on 12th December, Brexit will not be done on 31st January. Just as that's the easy bit in settling our relationship with Europe, having made a firm decision about what NOT to do, TWBC councillors now they (and we) need to come up with a solution of what IS going to happen. I am happy to say that there is progress on that front – more later – but there's still a huge amount of work needed.

Last year I also said how much I regretted the tone of the debate about Calverley Square and I spoke about how discussion within the Town Forum had been much more measured – expressing support for the objectives and ambition but raising concerns about specifics. As a result of that stance, I was pleased to lead a non-political team of volunteers to make suggestions about a way forward. We submitted that report to the Borough Council at the end of the summer. I have reason to believe that its suggestions were welcomed as, following the rejection of the Calverley Square plan, I was invited to attend a series of crossparty meetings to discuss possible alternatives. The title belies the style of the work going on, because none of the parties are particularly cross. In fact, there is a remarkable degree of agreement. So much so, that I am sometimes reminded of the last sentence from Animal Farm.

The creatures outside looked from pig to man, and from man to pig, and from pig to man again; but already it was impossible to say which was which.

I am not suggesting that some of the councillors are the said animals, just that there seems to be unanimity amongst former foes.

As I have said on many occasions, it is the role of the Town Forum to raise concerns, to ask questions and to make suggestions. To be a critical friend to our elected representatives. It is up to Borough and County Councillors as elected representatives to decide whether to take notice.

We really appreciate the time that Borough Councillors give to spend yet another evening in the Town Hall, but I'd rather hoped for better attendance. Those that do come always tell

The Town Forum now has 51 member organisations, 44 of whom attended at least one meeting in the year and 9 attended all meetings. We had an attendance rate of 70% this year, which is remarkable. My thanks to you all, not just for attending, but for all your positive contributions. We welcomed 4 new members in the year

and didn't lose any, although there are 4 or 5 about whose existence I am uncertain.

I am also aware of another couple of organisations in the pipeline. But we need more, particularly in the less well-represented parts of town. I had planned to hold at least one of meetings outside of the Town Hall in 2019. We need to go that in 2020.

The effort and expertise contributed by so many in the Town Forum is fantastic. Not just the working group chairs, although that is immense, but the members who voluntarily put in hours and hours of unpaid, but I hope not unrewarded, effort. These groups are where the work of the TF really happens, but we need more volunteers.

Linda Lewis is stepping down from leadership of our culture leisure and tourism working group. Someone wanted that renamed Tourism, Leisure and Culture, or TLC as it should more properly be. I don't know how Linda found time to be chair while masterminding this year's brilliant puppetry festival. Work has continued, of course on the Calverley Square project as well as the Emilia Scott cultural centre and we are indebted to both Linda and to Alex Green for their professional expertise, as well as all the other members of the group.

A lot of the controversy over Calverley Square has been about money and, with new plans being considered, I know that David Wakefield's Finance Working Group will continue to have its work cut out to scrutinise the Borough's income and spending plans over the coming 12 months.

I spoke last year about whether the efforts of Mark Booker and his Strategic Planning Group were making a difference to the shape of the Local Plan, which provide the bulk of the work this year. Whether or not it was due to the Town Forum's contribution, a lot of our recommendations do seem to have found their way into the published Plan. If you have read the Town Forum's input, you will appreciate the monumental scale of Mark's effort.



Not only has he managed to paint a big picture of the messages that we wanted to get across, he has gone into an inordinate amount of detail. I hope that other members of the management group won't mind me 'marking' him out for a special mention this year.

In the previous year (2017-18) Mark and his group were involved with the Public Realm phase 2 and I am pleased that we will talk about that a bit later tonight. Maybe I could remind you of my words last year.

"Our response to the Public Realm phase 2 has been less well-received. The original designs envisaged a new square in the middle of the town, something of which we could all be proud. As far as I can see, the latest design is little more than a slight narrowing of the road and a better view of the War Memorial. Both are welcome, but, in my views, don't justify the cost."

Looking at it today, I'm not sure that I would want to change much of that. It is a definite improvement, but I still feel it is an opportunity missed to have done something more dramatic.

At last year's TF AGM, Alastair Tod indicated his wish to stand down. I am delighted that he didn't really mean it. We co-opted him back on the management group anyway and he is standing this year as Deputy Chair again. Thank you so much for all your work in the working groups Alastair and your personal help to me.

It is an accolade to Michael Holman's Water in the Wells Group that he is the subject of Mary Harris's column in this week's Courier. Well done Michael. The theme of water seems to be a sine qua non in new developments and I am confident that progress is being made for more public art at Fiveways.

I'm also delighted that we have recruited Marianna MacDonald to lead the health and wellbeing group. The work that they and the Soroptimists did on auditing benches in the town was outstanding and really useful. Those amongst us who are readily able to walk (or cycle) everywhere underestimate the value of benches for those that need a breather every so often. The difference between someone being able to walk home or catch a bus / cab might well be a bench on Grosvenor Hill...one that has been lost over time. I look forward to seeing more benches around town

The list of topics discussed by Jane Fenwick and her Transport Working Group continues to lengthen. As well as attending and speaking at most JTB meetings, the working group has responded to numerous consultations, most notably and recently, the transport parts of the Local Plan. Again, it is a testament to Jane's input, that the mentions of transport in the Local Plan are so positive.

The groups have also contributed to the Local Cycling and Walking Infrastructure Plan, due to be submitted by the Brough Council this week. We performed an audit of the walking routes into town. The results confirmed what we probably already knew. Walking into the centre of Tunbridge Wells is a challenge – broken bricks, lack of road crossings, high volumes of fast traffic. No wonder that 12 pedestrians have been knocked over in the past 12 months in our town.



I remind you of the TfL report on the positive impact walking and cycling and public realm improvements which can increase sales on the High Street by 30%. Such interventions led to a fall vacancy rates of 17% and a rise in retail rental values by 7.5%. Over a month, people who walk to the high street spend 40% more. If anyone is in any doubt, a survey from a London Borough reported that 63% of businesses thought that their customers arrived by car, against just 20% of customers said actually did so.

What else? RTW in Bloom – yet more success. Thanks to Katharina in particular – we'll hear the details of all the Gold and Silver medals from you later.

Two highlights for me from the same meeting. Dr Stephen Peckham on the shocking state of air in Kent - much worse than we imagined, followed by students from schools talking about climate change. They were so eloquent, and we can learn a lot from them. So much so that I look forward to setting up a Youth Town Forum next year.

What else for Next year? More work on the Local Plan, particularly the transport aspects; and more on the alternative to Calverley Square. I am particularly pleased to announce that the cabinet has agreed to make one of its members – David Scott – responsible for liaison with the Town Forum. This puts us on a more equal footing with parish councils, about which I am delighted.

The Town Forum remains as relevant as ever. As I said last year, long may it continue to be a channel for unbiased information, a fake news free zone. But we need more help. We need more people to join the Forum and to volunteer time on the working groups.

Finally, an apology and a few thanks.

If I have forgotten to mention something, or someone, I'm really sorry. There are simply too many great things to talk about and I started writing this speech at about 4pm today!

Special thanks to the members of the management group, who put up with my whims and my lack of organisation and without whom the Town Forum would simply not function.

Secondly, Katharina Mahler-Bech, who maintains our website and social media accounts. We have a twitter account and there are frequent posts about relevant information. As of 2 hours ago, we were at 769 followers, a 20% increase on last year. Well done Katharina. The hashtag is simple... it's @townforum.

Thank you to William Benson and his team for their continued support of the Town Forum. The level of engagement with the Town Forum from the Borough Council has been excellent this year and a positive improvement on previous years. I hope and believe that the TF's input has been useful. There has been quite a lot of change within Democratic services, but I'm delighted that Mark O'Callaghan has [been] volunteered to help the Town Forum. It's only been a couple of months, Mark, but you are already making a positive difference. Long may it continue.

My biggest thanks go, of course, to my wife, Louise and to our family, for their forbearance and support. The standard morning conversation in our house often starts with Louise asking me what I am doing today, to which the correct response should be doing some paid work. The actual answer is, well, I've got to go down to the town hall for a meeting about...



As I said last year, I am happy to continue as chair for a further year, if you want, but I don't think it right that I repeat that sentence next year. I can't stress how enjoyable the role is. There is almost no responsibility and plenty of opportunity to stick your nose into other people's business, asked or unasked. Please, please, please will someone volunteer for next year.

MINUTES OF THE MEETING DATED 12 SEPTEMBER 2019

b) Matters Arising

None

UPDATE FROM THE LEADER OF THE COUNCIL

- 5 Councillor McDermott (Leader of Tunbridge Wells Borough Council) and Stephen Baughen (Head of Planning, TWBC) gave a verbal update and answered questions which included the following matters:
 - There was a new Leader of Kent County Council Roger Gough (Sevenoaks Borough Councillor).
 - Amelia Scott:
 - Work due to begin at the end of January 2020.
 - Due to complete at the end of 2021.

- Accessibility was very good, but it was suggested that an additional disabled car parking space be provided at the rear of the building for those who would find the distance from the War Memorial side too far.
- o Funding for the scheme was secure.
- Public Realm work was almost complete. Remaining work would be carried out in early 2020.
- The new Waste Service was slowly improving. Officers had worked very hard to rectify the issues that arose. Resources would be increased over the Christmas period.
- The Leader agreed to attend the next Tunbridge Wells Access Group Meeting. Andy England to send details of next meeting date.
- Climate Emergency declaration:
 - o Cross-party Working Group had been set up.
 - 2 meetings had taken place with Terms of Reference and an outline programme agreed.
 - First stage of the programme was to commission a Carbon Footprint Audit. Then put forward an action plan.
 - Second stage, a Forum to be set up to engage with young people and other stakeholders.
 - Suggestion that the Carbon Footprint Audit not be restricted to the Council as this would have limited impact. It needed to cover the whole Borough.
- No power existed to revoke the CPO that related to the Calverley Square project. As such it would remain until May 2022 but the Council had no intention to implement it.
- £900 had been raised at a quiz held by the Friends of the Tunbridge Wells Museum, Library and Art Gallery for the preservation of the Georgian Gown.
- Local Plan:
 - Consultation period ran from 20 September to 15 November 2019.
 - A wide consultation process was undertaken and several thousand comments were received – including from neighbouring authorities. These were now being uploaded.
 - Comments would then be reviewed by officers. This process would continue until summer 2020. Work with the Neighbourhood Development Group would also take place.
 - Subject to any amendments, a further consultation period would be undertaken between August and September 2020 for a period of at least 8 weeks. The aim would be to submit the plan by the end of 2020.
 - Policies associated with Climate Change and Active Travel were already included in the draft Local Plan. Consideration would be given to any further comments made, but it was noted that the key period of time for making representations had now passed.
 - Health was a key element of the Plan, particularly around infrastructure and health provision. The Infrastructure Delivery Plan provided further details of infrastructure provision and how it was being planned.
 - The presence of a Plan was fundamental to having a structured planning process and avoided a scenario of planning by appeal.

 Well being would be included as part of the Plan, with consideration given to smaller infrastructure items, e.g. benches.

CIVIC COMPLEX CROSS-PARTY WORKING GROUP

- 6 Councillor Scott, the Chairman of the TWBC Cross-party Working Group, gave a verbal update and answered questions which included the following matters:
 - Draft Report due to be available on 9 December 2019, to be presented at Full Council on 18 December 2019.
 - Membership of the Working Party was not commonly known at this time, this was to allow members to focus during the early stages.
 - There would be opportunities to comment as the work progressed.
 The Town Forum would be actively encouraged to make strong representation on the work going forward.
 - There was no power to revoke planning permission on the Calverley Square grounds.

PUBLIC REALM WORKS, LOCAL TRADERS AND RESIDENTS

- Paul Taylor, Director of Change and Communities, TWBC, gave a verbal update and answered questions which included the following matters:
 - Work was nearing completion. The outstanding work included:
 - Dressing to the steps by the war memorial. The stone arrived on 27 November, with work due to start soon and expected to be completed early in the new year.
 - Further work was needed on signage.
 - o Tree planting either side of the memorial.
 - Work was being undertaken on the wall outside the library.
 - The scheme would be reviewed 1 year and 3 years after implementation.
 - A closedown report would be produced and would include 'lessons learnt'.
 - Once signing had been reviewed and amended as necessary, there would be a period of transition prior to any enforcement measures being introduced.
 - Benches would be introduced, further details on their design and placement would be provided when known.
 - A meeting had taken place with residents from York Road and Dudley Road to discuss their issues regarding an increase in traffic and associated safety concerns. The position was being monitored.
 - There were currently no plans for a third phase of the scheme.
 - TWBC were meeting KCC where the issue of tree maintenance would be discussed. The outcome would be fed back at a future meeting.
 - It was not normal practice to put a Tree Preservation Order (TPO) on Highways Authority trees.
 - A working group was set up to discuss issues raised by local traders.
 TWBC wrote to the 48 businesses in the immediate vicinity to request information to be submitted to the Valuation Office Agency. TWBC received 16 responses, although not all provided evidence of material loss. The 16 cases would be submitted to the Valuation Office Agency who would consider and reply direct to the businesses involved.

HAWKENBURY PUMP TRACK

- Paul Taylor, Director of Change and Communities, TWBC, gave a verbal update and answered questions which included the following matters:
 - Scheme put forward by Hawkenbury Village Association.
 - A Pump Track to sit adjacent to the all weather track.
 - A presentation took place at RVP 3 sites were identified to start the discussion. Over 100 people supported the scheme, with only 2 people unhappy with the proposed sites.
 - More research was being undertaken by Hawkenbury Village Association. Once this had been put together, further liaison with the Council would take place.
 - Funding was expected to come from Community Funding from Barclay Homes. A grant application had also been submitted to the British Cycling Association.
 - Hawkenbury Village Association agreed to present at the next Town Forum meeting.

TUNBRIDGE WELLS IN BLOOM

- 9 Katharina Mahler-Bech gave a presentation and answered questions which included the following matters:
 - Royal Tunbridge Wells received Gold in the South and South East in Bloom awards.
 - It also received a number of other awards (parks, small parks, cemetery etc.).
 - Sherwood Close in Hawkenbury received a special award.
 - Royal Tunbridge Wells also received a Gold from Britain in Bloom.
 - The scheme was launched each year in April and everybody was encouraged to participate.
 - A photographic competition had taken place, with prominence given to horticultural themes. The results would be announced in the RVP in December. There would be a small exhibition of the 12 winning photographs.
 - 2020 would be the tenth year and the theme would be sunflowers.

UPDATES FROM LOCAL RESIDENTS' GROUPS

Michael Holman noted that friends (local store holders) from Wiesbaden were due to visit 13,14 and 15 December 2019. They would be located (as usual) near the ice rink.

HISTORIC ZONE 20MPH

- Adrian Berendt gave a presentation and answered questions which included the following matters:
 - Proposal for a 20mph zone in the historic centre of Tunbridge Wells.
 - The new proposal would include Inner London Road out to Prospect Road, Calverley Road, Calverley Park Gardens, Monson Road, Camden Road etc.
 - Town Forum to support the scheme with the aim of putting it forward to the next Joint Transport Board meeting in January 2020.
 - There was a need to ensure that any measures introduced forced drivers to adhere to the 20pmh speed limit.

- Members made a number of suggestions for additional roads to be included as part of the proposal:
 - o Camden Hill,
 - o the upper part of Church Road
 - o Culverden Down
 - A26 (Mount Ephraim Road)
 - Sandrock Road (particularly outside St James School).
- Education about speed limits was important but it was recognised that this took time.

REPORTS FROM THE TOWN FORUM WORKING GROUPS

- 12 Culture, Leisure and Tourism Working Group:
 - Working Party Report on Culture Strategy page 42, 'Planning should recognise the need for a robust business plan but not be dominated by seeking to avoid an operating deficit which could be traded against capital costs'. It was agreed that an explanation of this would be provided later.

Water in the Wells Working Group:

- The Fountain in Dunorlan Park it would be nice to see it in operation on a more regular basis.
- Reference to water features and water health in the Town.
 Developers would now be guided towards this.
- The Beacon was not going to restore the old bath, but to build a new one. A cold bath and a new hot bath.

Wellbeing Working Group:

 Nourish Community Food Bank to hold a fundraiser on 7 and 8 December in RVP.

Tunbridge Wells Town Forum Strategic Planning Working Group Update report for the meeting on 30th January 2020

Local Plan development

There was not enough time at the last Forum meeting to report on the response submitted on behalf of the Town Forum to the formal consultation on the Preferred Draft Local Plan which had been extended to 15th November 2019. The response has been circulated to members and ran to some 69 pages. There is much to welcome in the draft, such as setting higher standards for building design, serious attempts to encourage more affordable housing, initial policies on climate change mitigation, more specific heritage policies and continuing protection for much of the Green Belt immediately surrounding Royal Tunbridge Wells. We did though, among other things, express concerns over the possible loss of parts of existing playing fields, even if this is predicated on major development of replacement state of the art facilities at Hawkenbury Rec.

With regard to overall policy objectives, we advocated placing *wellbeing* at the heart of all policies with an additional specific objective of seeking to enable it in the Borough. This would range from the provision of adequate benches and public toilets in the town centre, improved doctors' surgeries, through changes to primary school provision to enable access to local schools by local residents, to the positive enabling of active travel by provision of adequate walking and cycling routes in and around the town centre.

1. Housing numbers and housing need

We took into account the continuing political realities of acute government pressure on local authorities to allow substantial building in their areas, even beyond the latest calculated housing need, in making our response. It seems clear from the rejection of both the draft Sevenoaks and Wealden Local Plans that there is a determination in government to override local concerns and even some of the stated policies in the National Planning Policy Framework. Against this troubling background, TWBC's decision to endeavour to produce a plan which will be found "sound" by the Planning Inspectorate at Public Examination does appear pragmatic if not ideal. We *do* need an up to date Local Plan as soon as possible so that the worst kind of unplanned development does not take place in default. There is currently no reason to hope that a more logical framework for housing numbers and housing need will emerge from the current national administration and it is probably only in pressing for greater density of development to prevent urban sprawl that we have much chance of influencing events locally.

2. Allocations policies

The proposed specific building allocations for Royal Tunbridge Wells were subject to extensive consultation with the Town Forum WG throughout 2019, including half day workshops in February and September. The overall view was that the proposed allocations were either satisfactory or in the case of proposed encroachment into Green Belt and AONB, probably the "least worst" options. Concerns remained over the proposed development at Spratsbrook Farm in the AONB where great care would be needed to avoid harming the views towards Crowborough Beacon from the Beacon Hotel and Rusthall Common. Our comments on a site by site basis are available in our full response.

3. Transport and other infrastructure

TWBC is not in control of most of the public infrastructure in Royal Tunbridge Wells. The draft Infrastructure Delivery Plan and Transport Strategy Review (available on the TWBC Local Plan website) are excellent aspirational documents but we felt that the policies on transport and water infrastructure in particular were over-optimistic and liable not to be delivered in time to meet the increased demand arising from new development. However, there were also encouraging signs that, in policy terms at least, active travel and reduction in atmospheric and noise pollution had become

mainstream objectives, along with longer term objectives of re-opening rail links to Brighton and Croydon.

4. Revised Local Plan timetable

The approximate timetable for development of the new Local Plan is currently as follows: Final Local Plan consultation (Regulation 19) August-September 2020; Submission of Final Local Plan December 2020; Public Examination of Plan Spring 2021; Entry into force Autumn 2021.

Personal note

I first attended the Forum at the beginning of 2014 on behalf of the Culverden Residents' Association and since then have not missed a meeting. June Bridgeman first involved me in working on an outline for a report on green issues to complement her earlier paper "A place of pleasure and resort". This led to our 2015 report "Developing our Green Network" advocating protection and enhancement of our green spaces and development of green routes for active travel as part of a policy to develop Royal Tunbridge Wells as a destination town. In the late autumn of 2014 I was privileged to take over the planning brief from the late Michael Doyle who had so assiduously followed planning matters at TWBC for the Forum since its formation but was sadly in failing health. I have now completed over 5 years in the role and it has been interesting and rewarding and is still very much a learning experience.

I tried from the start to engage positively with the excellent planning policy team at TWBC whose dedicated mid-level officers have mostly been in post for many years and ensure valuable continuity for our town in a world of constantly changing government planning diktats. After several years of instability at the top, we now have a capable internally promoted Head of Planning in Steve Baughen, with whose team we have consulted on all aspects of the Draft Local Plan. The Town Forum is not a statutory consultee in the same way as a Parish Council and it is particularly pleasing that we have been treated as though we were one during the Local Plan process and have respected the confidentiality that would be required of a statutory consultee. As a result, we have been able to make a substantially stronger input to the whole process than in previous consultations. I have also sought to divide the planning workload logically between the Forum and the Civic Society with the Civic Society using its long-standing expertise on individual planning applications while the Forum has concentrated on more strategic issues. I hope this has made it easier for both organisations to work effectively on planning as a whole with the limited resource available to us.

On the issue of resource, shadowing a whole team of TWBC Officers involved with many different planning issues has proved gruelling and has required fairly relentless effort over the years. In seeking to build up a representative working group, I hoped that members would take on primary responsibilities according to their particular interest in housing, retail, employment, infrastructure and so on with me acting as co-ordinator and editor, but in practice this has not proved achievable. Active members of the Forum are mainly, like me, also involved elsewhere and have limited availability for detailed work. Preparation of the TF response on the Draft Preferred Local Plan therefore involved me in some 26 full working day equivalents in researching, meetings and writing between September and mid November and this is not at present a sustainable pattern for me. I have several years' backlog of personal matters to attend to and also some personal projects I would like to take forward. I therefore seek your indulgence to take a break from all but unavoidable business until the Local Plan process resumes in the late summer. The time may also come when you feel it would be appropriate for someone with fresh ideas and time capacity to take on some or all of the planning work now that our input is well established and respected within Council circles. Besides continuing to represent Culverden Residents' Association, I hope in any event to continue with input on green issues and sustainable transport which is what first brought me into the Forum in 2014.
